**PUBLIC NOTICE**

Notice is hereby given in pursuance of section 9 (1) (a) of the Delhi Water Board Act, 1998 that in the area of state of Delhi as specified in the Schedule below, water is available from the water source of the Board for reasonable supply to all the lands and building in such area.

It is notified, that development charges for water @ 440.00 Per Sq. m. of the plotted area are recoverable, subject to following terms and conditions :

- (a) water development charge would be recoverable at the rate Rs. 100/- per sq.mtr for properties used for residential purposes having area upto and including 200 sq.mtr. upto 03 months from the issuance of this public notice as per notification No. DJB/DOR/D.D.(R)HQ-II/2015/7379 to 7567 dated 29-06-2015, or the last date of extended period of scheme of reduced rates of development charges as per notification No. DJB/DOR/D.D.(R)HQ-I/2018/327-465 dated 18.01.2018 whichever is later.
- (b) If a consumer is unable to pay the development charges as pr the notified rates in lump sum or in part, then in that case simple interest @ 10% per annum will be levied on expiry of 12 months period from the date of this notification of service in the colony.

The plot-holders/ occupiers are advised to apply for sanction of water connection in the prescribed form which may be obtained from the office of the **Zonal Revenue Officer (North) II, Majlis Park, Kewal Park, Delhi-110033**. The form can also be down-loaded from DJB's website [www.delhijalboard.nic.in](http://www.delhijalboard.nic.in) After sanction of water connection and payment of initial charges, water development charges and road restoration charges, the applicant shall be allowed to obtain boring permission and executing the work at his level by engaging a licensed plumber. The onus will be on the plot-holders to get the bills from above office of D.J.B for development charges to be paid.
