PUBLIC NOTICE

Notice is hereby given in pursuance of section 9 (1) (a) of the Delhi Water Board Act, 1998 that in the area of state of Delhi as specified in the Schedule below, water is available from the water source of the Board for reasonable supply to all the lands and buildings in such area.

It is notified, that development charges for water @ Rs.440.00 Per Sq.m. of the plotted area are recoverable as per formulae given here under:

- (a) Water development charge would be recoverable at the rate Rs.100/- per sq. mtr. for properties used for residential purposes having area upto and including 200 Sq. Mtr. upto three months from the issuance of this Public Notice, as the colony is eligible as per Notification No.DJB/DOR/DD(R)HQ-II/ 2016/1107 to 1242 dated 31-01-2017/ No.DJB/ DOR/DD(R)HQ-II/ 2016/11991 to 12129 dated 28-11-16/ No.DJB/DOR/DD(R)HQ-II/2016/10650 to 10794 dated 30-09-2016 No.DJB/DOR/ DD(R)HQ-II/2016/8116 to 8252 dated 15-07-2016/ No.DJB/ DOR/ DD(R)HQ-II/2016/1201 to 1325 dated 02-02-2016/ No.DJB/DOR/DD(R)HQ-II/ 2015/ 7379 to 7567 dated 29-06-2015.
- (b) On expiry of the aforesaid scheme of reduced rate of development charges, if a consumer is unable to pay the development charges as per the notified rates in lump sum or in part, then in that case simple interest @ 10% per annum will be levied on expiry of 12 months period from the date of notification of service in a colony.

After sanction of water connection, payment of initial charges, including water development charges, road restoration charges and water connection installation charges, M/s. NWS Pvt. Ltd. will install the water connection from DJB water line to the boundary of applicant's property. The onus will be of the plot-holders to get the bills from above office of D.J.B. for all charges to be paid for taking new water connection.
