Delhi Jal Board proposes to empanel practicing Advocates as Panel counsels and Standing Counsels for Supreme court/High Court/CAT/CCI/District civil courts/ Consumer Forums/ Labour court etc. The eligible and willing advocates having required qualification and experience may apply in the prescribed proforma. The Standing counsels/ Additional standing counsels/ Panel lawyers of DJB may also apply in the prescribed format for fresh empanelment if they desire.

Qualification and Experience for Standing Counsel in Supreme Court:

- (1) Bachelors degree in law from a recognised university and registered with any Bar council of Delhi.
- (2) Having practice as an advocate for not less than 15 years in Supreme Court of India and must be an advocate on record and should have a chamber in Supreme Court/ High court.
- (3) Having good communication skills and good knowledge of law and procedure.

Qualification and Experience for Standing Counsel in High Court:

- (1) Bachelors degree in law from a recognised university and registered with any Bar council of Delhi.
- (2) Having practice as an advocate for not less than 12 years in Delhi High Court and should have a chamber in High court.
- (3) Having good communication skills and good knowledge of law and procedure.

Qualification and Experience for Additional Standing Counsel in High Court/ CAT:

- (1) Bachelors degree in law from a recognised university and registered with any Bar council of Delhi.
- (2) Having practice as an advocate for not less than 12 years in Delhi High Court/CAT and should have a chamber in High court/ CAT/ District court.
- (3) Having good communication skills and good knowledge of law and procedure.

Qualification and Experience for Panel Advocate:

- (1) Bachelors degree in law from a recognised university and registered with any Bar council of Delhi.
- (2) having practice as an advocate for not less than 10 years in Delhi High Court/CAT/ District Court / District Consumer Forums/ Tribunals etc. and should have a chamber in High court/ CAT/ District court to be engaged as Panel Lawyer.
- (3) Having good communication skills and good knowledge of law and procedure.


Qualification and Experience for Panel Advocate on Retainership basis:

- (1) Bachelors degree in law from a recognised university and registered with any Bar council of Delhi.
- (2) having practice as an advocate for not less than 07 years in Delhi High Court/CAT/ District Court / District Consumer Forums/ Tribunals etc. and should have a chamber in High court/ CAT/ District court.
- (3) Having good communication skills and good knowledge of law and procedure.

Mode of Selection:

- (1) The mode of selection will be interaction by selection committee.
- (2) The department reserves the right to decide the criteria of short-listing the applications on the basis of number of applications received.
- (3) Candidates so short listed will then be called for interaction. Intimation will be sent at the correspondence address given in the application form or/and over the telephone number/ e-mail given by the applicant.
- (4) Candidates will have to produce all original documents at the time of interview/ interaction.
- (5) The engagement will be initially for a period of two years which may be extended after 02 years subject to the satisfactory performance/ conduct of the counsel.
